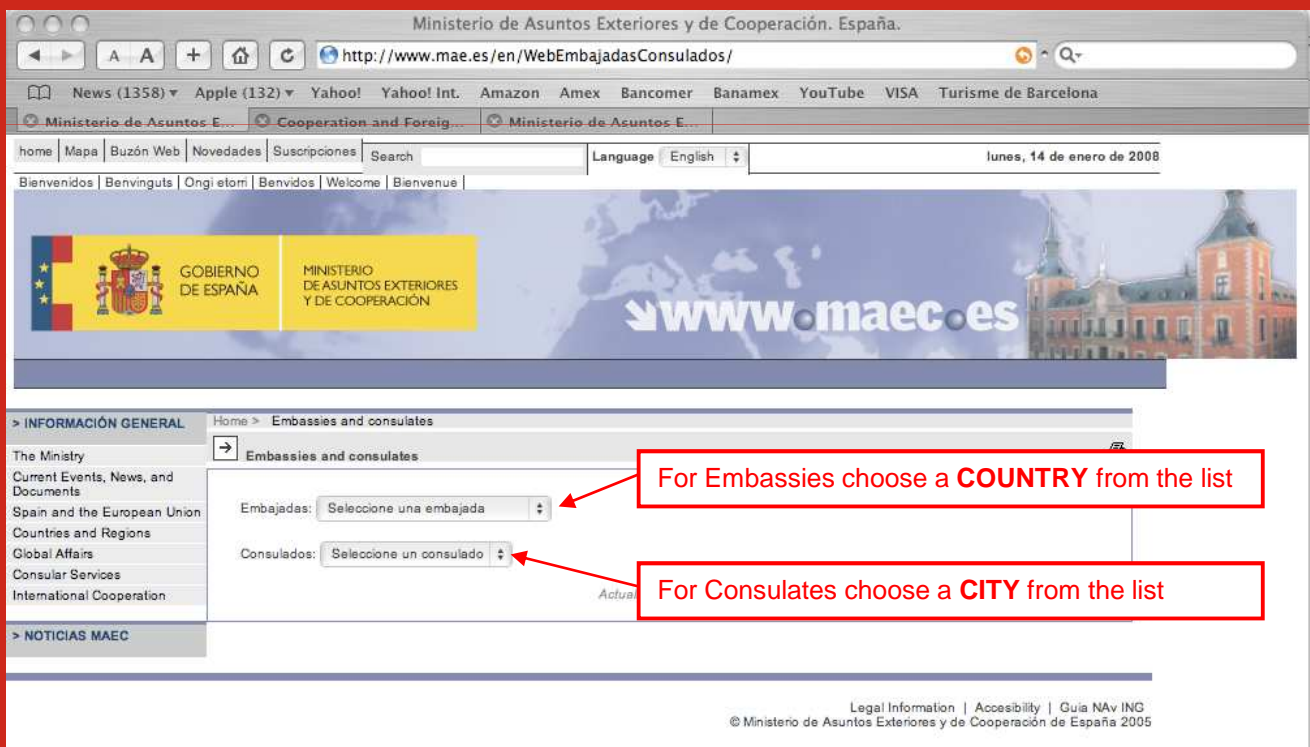

4) HOW TO OBTAIN AN INVITATION LETTER IN ORDER TO APPLY FOR A SPANISH VISA?

When applying for a Spanish Visa, one of the various requirements that you will be required to meet is the evidence proving the purpose of your visit to Spain.

In this case your reason for visiting the country is the 19th IHRA's International Conference and the evidence/proof to provide will be your letter of invitation issued by the conference organisers.

In order to obtain the invitation letter, please send an email with your request to **Saul Saldivar**, as follows:

Please ensure that the following information is included in your email:

- ✓ **Full Name (as it appears in your passport)**
- ✓ **Passport Number**
- ✓ **Date of Birth**
- ✓ **Date of Issue and Expiration of your Passport**

IMPORTANT NOTE: The request of an invitation letter does not guarantee it will be issued. In the case of request(s) being declined, you will be contacted directly with the explanation .

5) GENERAL REMARKS

✓ When applying for a Spanish Visa, we strongly recommend and advise that you start the procedure at least 2 months prior to the conference

✓ Before travelling to Spain, even if you do not need a Visa, we encourage all delegates to seek information provided by the Spanish Ministry of Foreign Affairs , as you may be requested to present evidence in relation to your visit upon arrival (i.e. hotel reservation, round trip ticket).

✓ Invitations are only issued to registered conference participants with no outstanding fees. In order to register, please visit www.ihraconferences.com/2008

✓ A full refund upon Visa rejection is provided when the authentic written refusal from the Embassy/Consulate is presented. A copy must be forwarded to the conference organisers (attn. Saul Saldivar) via post, fax or email using the following details:
